HPF Procurement and Distribution of Essential Drugs and Medical Commodities for South Sudan

Procurement

Consignment C10 – This is in production and we are waiting on Tax Exemption for the arrival of infusions. Tax Exemption for the kits will start in a couple of weeks for the arrival of stock and all kits are expected to be in Juba by mid-December. Distribution forecasted for February 2020. **Consignment C11** – The contract has now been awarded to Missionpharma who were the successful bidder to be the supplier for C11, 12 and C13. Distribution for C11 is forecast for June 2020.

International Freight/Tax Exemption

C10 Infusions should arrive in Monbassa approximately 27 October and will then be road moved to Juba. All Tax Exemption for Kits will start in the next couple of weeks.

Consignment 9 Distribution Update

We have now received authority from MOH to start the distribution. The carriers will be nominated and we shall get the security clearance from National Security during week of 7 October. The Distribution, if all security clearance given, will commence week of the 14 October. The Distribution Manager will give out all details in due course. The IP MedLog must now prepare themselves for the receipt of this consignment. The BHI stock is in PHCC and PHCU kits. The C9 distribution will include the following items:

Kits – Referral Hospital x 2, State Hospital x 8, County Hospital x 15, PHCC High x 93, PHCC Low x 101, PHCU x 585. This is a total of 804 authorised HPF supported facilities.

UNFPA stock – The IP MedLog will provide assistance to move the UNFPA stock to the HPF supported facilities.

Registers – PMIS/HMIS registers for holding at the CHD and facilities can request them when required.

The distribution will be a mix of air and road and Brian Bloor the HPF Distribution Manager will provide the detail of the distribution schedule in due course. The IP must remain flexible as this is a huge task that needs cooperation from both parties.

IP Last Mile Delivery

It is imperative that we receive LAST MILE proof of delivery for all HPF supported facilities. HPF provide the invoice for Last Mile delivery to each named facility. The IP MedLog must get invoices signed at the facility and return the first and last page for each invoice as proof of delivery. Your contract is to deliver within 21 days of receipt at your respective CHD. The IP must inform HPF Contracts, with justification, if this is not achievable. This must be a priority. Remember that HPF stock is for HPF facilities only. Any buffer stock that is held at the CHD must be monitored and controlled to ensure its security. Work in partnership with the State Ministry of health and CHD. Use the Drug Management Committee to emphasise this point.

Consumption Data

The IP MedLog is to ensure that Consumption Data reporting for September is completed and submitted by the 15 October. This data is essential for the HPF supply chain to determine smart procurement. A point to note is that we received 89% of the reports but we must aim for 100% as we move forward.

IP Medical Logisticians

The IP MedLog must submit their MedLog SITREP for September by 15 October. The MedLog must remember that all BHI stock taken by the BHI workers from PHCC and PHCU must be annotated on the Pharmacy/Dispensing stock cards as *"Issued to BHI + Name of worker"*.

You must have a monthly Drug Management Committee. Remember the HPF Supply Chain staff is here to provide assistance or advice when you need it.
